

Frequently Asked Questions

What is a Donor-Advised Fund?

A donor-advised fund (DAF) is a specialized financial account for charitable giving. It allows individuals to make a charitable contribution, receive an immediate tax deduction, and then make grants to 501(c)(3) organizations over time.

Why do DAFs Matter?

DAFs account for 17 percent of annual giving in the US, contributing nearly \$52 billion. They're the fastest-growing philanthropic vehicle, with a 28 percent increase in giving in 2020 and 2021. The average DAF donation is \$5,000—24x larger than a typical credit card gift.

Why is it important to make it easy for donors to give with DAFs?

On average, donors make gifts that are 10x larger via DAFs and they do so 6x more often w. DAFpay's intuitive design displays the donor's balance, encouraging larger gifts from both new and existing DAF donors.

Do I have access to DAFpay and how much does it cost?
